EVENTS AT THE RANCH - POLICIES / RULES / TERMS 2024-

1. **<u>TIMES-</u>**

- a. Vendors need to be set up and ready to sell their products/items/merchandise at least 30 minutes before the event opens.
 - i. Vendors should have everything unloaded and ready to set up at least 1 HOUR before the event starts.

2. <u>PARKING-</u>

3. <u>ELECTRIC</u>

- a. You must bring in your own electric cords, extension cords, & adapters (if needed). The Kettle Moraine Ranch will not supply any vendors with such items.

4. LOGOS/ADVERTISING-

- b. The Kettle Moraine Ranch will promote vendors on our website and facebook page leading up to the event dates.

5. <u>PAYMENT-</u>

- a. Payment for vendor space is due 30 days before the event date.
- b. No refunds will be given if vendors decide to cancel coming to the event.
- c. The Kettle Moraine Ranch only accepts Cash, WI Checks, Money Orders, or Cashier Checks for payment.
